

AMENDED ORDER RECALLING CERTAIN ACTIVE CAPIASES ISSUED ON
BOATING CITATIONS PRIOR TO JANUARY 1, 2006

WHEREAS, there exists a number of outstanding capiases issued prior to January 1, 2006, on boating citation cases which the Orange County Attorney's Office has taken no action to prosecute; and

WHEREAS, the manpower required for record-keeping along with the physical housing and storage of these exceedingly old capiases, places a tremendous burden on the Clerk of Court and interferes with the efficient administration of justice;

NOW, THEREFORE, I, Belvin Perry, Jr., pursuant to the authority vested in me as Chief Judge of the Ninth Judicial Circuit of Florida under Florida Rule of Judicial Administration 2.215 order the following effective immediately:

1. The Clerk of Court shall recall all outstanding capiases on all boating citations issued prior to January 1, 2006. The outstanding capiases are specifically listed and attached hereto as "Attachment A."
2. Due to a lack of prosecution, the Clerk of Court shall dismiss each case for which a capias was recalled, with the exception of case number 1991-MI-1819-A. This specific case will not be dismissed and shall only have the capias recalled.

THEREFORE, IT IS ORDERED that all outstanding capiases as listed in Attachment A to this Order, which were issued for a boating citation, prior to January 1, 2006, are hereby **RECALLED AND QUASHED.**

Administrative Order 2007-10 is hereby vacated and set aside due to a scrivener's error.
