Re: Background Checks for Guardians Residing Out-of-State

Attorneys,

If your client resides outside of the State of Florida and is applying to become a guardian, he or she must still undergo a background screening that includes finger printing. Please request a finger print card by e-mailing me at [ctadws1@ocnjcc.org](mailto:ctadws1@ocnjcc.org). Once the card is received, please forward it to your client with instructions to take the card to the closest law enforcement agency to be finger printed. Alternatively, your client may use a blank card (it must be card FD-258) obtained from a law enforcement agency and filled in with the appropriate ORI (FLO48094Z). Once your client has been finger printed he or she should contact a Livescan vendor (see attached list for "Hard Card Scanning Capable" vendors or visit <https://www.fdle.state.fl.us/cms/Criminal-History-Records/Documents/ApplicantLivescanService-ProvidersVendors.aspx>) in the State of Florida to determine the costs involved and mailing address. Then your client must mail the card, along with the required payment, to the vendor so that the card can be processed. Please instruct your client not to mail the card without first enclosing the payment or making payment arrangements with the vendor because the card will be destroyed or returned to them without processing.

The above instructions are only for those proposed guardians residing outside of the State of Florida. Those guardians living in Florida may use any law enforcement agency that provides the Livescan service or any Livescan vendor. However, the results must be sent to ORI FLO48094Z.

Florida Statutes 744.3135 (1) The court may require a nonprofessional guardian and shall require a professional or public guardian, and all employees of a professional guardian who have a fiduciary responsibility to a ward, to submit, at their own expense, to an investigation of the guardian's credit history and to undergo level 2 background screening as required under s. 435.04. If a credit or criminal history record check is required, the court must consider the results of any investigation before appointing a guardian. At any time, the court may require a guardian or the guardian's employees to submit to an investigation of the person's credit history and complete a level 1 background screening as set forth in s. 435.03. The court shall consider the results of any investigation when reappointing a guardian.

### **LIST OF APPLICANT LIVESCAN VENDORS AND SERVICE PROVIDERS WHO HAVE ESTABLISHED SUBMISSION APPROVAL FROM FDLE**

**Applicant type fingerprint cards may be submitted electronically to the Florida Department of Law Enforcement, *for the purpose of conducting a criminal history check*, IF the licensing or employing agency has agreed and made prior arrangements to receive electronic results from FDLE.**

- If the licensing or employing agency has established a system to receive the electronic results, the applicant will be given instructions (*from the agency*) as to where to go and how to have the fingerprints taken and submitted from a livescan device.
- If an applicant wishes to submit fingerprints electronically but the agency did not give instructions, please contact that agency and request that the agency contact FDLE and make arrangements to receive electronic results. Individual applicants cannot be accommodated without the agency involvement.

**Licensing or employing agencies MAY PURCHASE LIVESCAN DEVICES or MAY CONTACT SERVICE PROVIDERS to enable their applicants to electronically submit criminal history requests on their behalf.**
