5. The parties shall follow the rules and directives of the staff of the <b>Family Ties</b> program and law enforcement agency at all <b>Family Ties</b> locations. Failure to follow said rules and directives may result in the family being removed from the <b>Family Ties</b> program and/or the Court entering sanctions against the responsible party.
6. The parties shall notify the <b>Family Ties</b> program at (407) 836-0426 at least two (2) <b>business</b> days before the scheduled monitored visitation exchange if they cannot keep a scheduled monitored visitation exchange. Failure to do so will result in the parties being required to pay for the scheduled monitored visitation exchange. If two scheduled exchanges are canceled by either party within 30 days, said cancellations will be reported to the Court and no additional monitored visitation exchanges will be scheduled until further Order of the Court.
7. The <b>Family Ties</b> and law enforcement personnel at all <b>Family Ties</b> locations shall implement this Order by all lawful means to accomplish its purpose in providing safe and regular contact between the child(ren) and visiting parents.
