This document is a quick summary of the Judge's scheduling procedures, posted for your convenience. Please read the Judge's full procedures found on his page.

PROCEDURES FOR ORDERS SUBMITTED TO CHAMBERS:

All Submitted Orders:

E-filed cover letter: All proposed orders must be accompanied by an **e-filed** cover letter (the cover letter must have the filing stamp across the top) and must indicate that opposing counsel has reviewed and approved the form of the order when submitting to the Court for review. The cover letter (but not the proposed order) must be e-filed by the attorney with the Clerk of Court.

Agreed/Unopposed Orders: If "agreed" or "unopposed" orders are provided, the title must indicate the substance of the proposed order in addition to the indication that it is an "agreed" or "unopposed" order. Please DO NOT include the word "proposed" in the title of the order.

Certificate of Service: Please be sure that the certificate of service contained in the proposed order complies with the Rules of Civil Procedure.

Other Useful Information: The Court does not hold orders waiting for approval or objection. **Please do not send proposed orders to the Court until you have approval as to the form by opposing counsel.** If opposing counsel objects, it must be noted in the cover letter and the email submitted.

DO NOT INCLUDE your firm letterhead, logo, or internal file/claim number in proposed order. Also, with service through the e-portal, a line for the date of signature is NO LONGER NECESSARY.

Proposed Orders where all parties receive e-service: In addition to the above, all parties receive service through the statewide ePortal, the proposed orders(s) in Word format (never .PDF), along with a copy of the e-filed cover letter, may be emailed to 48Orange@ninthcircuit.org.

Proposed Orders where some parties receive service by U.S. Mail: In addition to the above, if any party receives service by U.S. Mail, overnight delivery, then the proposed orders and e-filed cover letter must be delivered in hard copy by U.S. mail, overnight delivery, or hand delivery to chambers on the 17th floor. The Judicial Assistant will e-file the Order but if there is a party on the case that is not on the ePortal then the packet provided to chambers must be accompanied by sufficient copies with stamped, addressed envelopes for all parties not receiving the order by e-service.

Orders are processed as the Judge has time out of court. If the Judge is out of the office, the orders will be processed upon return in the order they were received. Additionally, there may be a delay if the judicial assistant is out of the office. If you want to know if a specific order has been signed by the Judge, you should first check your e-service email as the Order may have been e-served. If not received by email, then check the Clerk of Court website to see if it has been docketed before contacting the Judicial Assistant.
