All exhibits and evidence must be tagged and pre-marked for identification prior to trial. According to the Clerk’s Office, evidence instructions and tags are available at the Orange County Courthouse, Monday to Friday from 7:30 a.m. to 4:00 p.m., in the Records division located in Room 150.

If a case settles, the Judicial Assistant must be immediately notified of any

settlement or resolution of any matter on the trial docket. The trial will not be removed from the actual docket, is subject to trial call, and the attorneys must appear in person, until such time as (1) as a Notice of Settlement has been filed, and (2) the Court has advised through email correspondence with the Judicial Assistant that the parties are relieved from appearing at trial call.

Proposed jury instructions and a proposed verdict form are due prior to the first day of trial unless an earlier deadline is established by the trial order or another order.
