JUDGE LATIMORE: Hi, I'm Judge Latimore.

MS. STEPHENS: And I'm Cathy Stephens.

JUDGE LATIMORE: And you are listening to 9th Unplugged.

JUDGE LATIMORE: So before we get unplugged, tell me what your job title is and the department that you work for.

MS. STEPHENS: I'm a judicial assistant to Judge John E. Jordan and right now we're in business court.

JUDGE LATIMORE: Okay. And how long have you been a judicial assistant?

MS. STEPHENS: I have been a judicial assistant for 15 years and before that I was a clerk for five years.

JUDGE LATIMORE: All righty. And you transitioned from the Clerk's Office over to becoming a judicial assistant, is that correct?

MS. STEPHENS: Yes. Yes.

JUDGE LATIMORE: All right. How do you like that position?

MS. STEPHENS: I love it. I've loved this job since day one.

JUDGE LATIMORE: What's the best thing about being a judicial assistant?

MS. STEPHENS: I think it's actually feeling like you're helping people. And you never know what's going to happen five minutes later --

JUDGE LATIMORE: Okay.

MS. STEPHENS: -- on that phone call.

JUDGE LATIMORE: Yeah. Yeah. That phone call makes a difference, doesn't it? All right, so we're going to get unplugged and we're going to stop talking about work. And we're going to talk about what you do outside of work. And what do you enjoy doing the most when you're not at work?

MS. STEPHENS: I am a mother of five and I have three that are grown and married. So I am all about planning family outings, family holidays, anything that will bring my family together.

JUDGE LATIMORE: Okay, and do you have an extended family, like a large, extended family outside of your children.

MS. STEPHENS: I have just a brother and a sister, not much. But my parents are still living and they're here and so they – we incorporate them in it as well.

JUDGE LATIMORE: And you get a chance to visit and spend time with them also.

MS. STEPHENS: Every opportunity we can.

JUDGE LATIMORE: So tell me about when you were growing up. Where did you grow up?

MS. STEPHENS: I grew up in Hutchinson, Kansas. I was a farm kid. We grew every vegetable you could think of.

JUDGE LATIMORE: Okay.

MS. STEPHENS: And lots of animals. And just worked hard, morning to night.

JUDGE LATIMORE: Do you miss that? Do you miss that farm life?

MS. STEPHENS: I enjoyed it then. I was just a kid and didn't know a whole lot any better, but I enjoyed – I think it taught me a lot about working hard and seeing things that you worked hard for, actually get something from it. And so I do. I think it made me who I am.

JUDGE LATIMORE: What's a fun thing that kids do on a farm that you don't see kids in the city doing? I didn't grow up on a farm so I would love to know what you all do for something exciting.

MS. STEPHENS: I remember my sister and I would just – we had a pony that – we had horses, but we had a pony that we were allowed to ride anytime we wanted. And so we would go get on the pony and just ride it around the yard. And pretty soon when it got tired of us, it would walk up next to a tree and knock us off. And it would go to the barn. We just knew we were going to the barn to get it again.

JUDGE LATIMORE: You just knew he had enough.

MS. STEPHENS: Yeah, and we had sheep and we had lambs. And it was fun to play with the lambs. And we had bunnies and chickens and –

JUDGE LATIMORE: Do you have pets now?

MS. STEPHENS: We have two dogs.

JUDGE LATIMORE: All right.

MS. STEPHENS: That's it.

JUDGE LATIMORE: That's it. Okay, how did you end up in Orlando?

MS. STEPHENS: My sister and brother already lived here and our older three children were getting into college age. And we wanted a little more opportunity college-wise for them. So we moved here so they could finish high school here, and go to college.

JUDGE LATIMORE: If you could change the world, how would you do that?

MS. STEPHENS: Well, right now, I'd like to get rid of COVID.

JUDGE LATIMORE: That would be nice, wouldn't it?

MS. STEPHENS: But I think for the most part, I would really like to get people to work together more. I think as – if everybody brings their knowledge together, I just don't see anything we can't fix.

JUDGE LATIMORE: Yeah.

MS. STEPHENS: And I don't think we work together very well.

JUDGE LATIMORE: Yeah.

MS. STEPHENS: Sometimes.

JUDGE LATIMORE: I agree with you on that. So there was something really special about your dad and when you grew up. Can you share that with us?

MS. STEPHENS: My dad was our – was the president of USA Boxing and he took – he promoted boxing tournaments all over the United States and did the nationals, and even went to the Olympics a few times and took boxers to the Olympics.

JUDGE LATIMORE: Wow.

MS. STEPHENS: And as kids, we just kind of tagged along and got to be a part of that for years.

JUDGE LATIMORE: Yeah, so was there anyone in particular that you remember meeting in the boxing world?

MS. STEPHENS: I met Leon Spinks. That dates but he had a little boy who had a – JUDGE LATIMORE: I was enchanted by Leon Spinks.

MS. STEPHENS: He had a little boy who did a 7-UP or Sprite commercial with him but I remember seeing him run around the ring. And Mike Tyson, I remember him as a little kid doing the Golden Gloves and went on to pro.

JUDGE LATIMORE: Did you go to the Olympics?

MS. STEPHENS: Yes.

MS. STEPHENS: And so –

JUDGE LATIMORE: Is that how they met?

MS. STEPHENS: I think you first have to be okay making the mistake. You just recognize you made a mistake, and we're all human and it's a good thing because we're not a robot.
