JUDGE LATIMORE: Hi, I'm Judge Latimore.

MS. FERRARA: And I'm Frannie Ferrara.

JUDGE LATIMORE: And you're listening to 9th Unplugged.

JUDGE LATIMORE: Before we unplug from work and we're going to dive deep into your life outside of the courts, would you tell us your title and what department you work in?

MS. FERRARA: So my title is communications coordinator and I work in the communications department, which is in court administration.

JUDGE LATIMORE: And exactly what do you do day-to-day at your job?

MS. FERRARA: Day-to-day we manage basically external and internal communications, social media, press releases, whether or not you know, the media are going to be here, how they're going to be here, you know, we manage any way communications happen.

JUDGE LATIMORE: All right. And you manage this unplug thing too, don't you?

MS. FERRARA: And I manage this unplug thing.

JUDGE LATIMORE: Well, that's great. We're so happy you do that. So let's go ahead and talk about what you do when you're unplugged.

MS. FERRARA: Okay.

JUDGE LATIMORE: All right, when you're away from work, let me ask you a question, do you stay on the phone a lot or are you one of those people that after work you don't want to communicate anymore?

MS. FERRARA: I used to be a person who stayed on the phone a lot but now I just do not, I don't. I don't want to be on social media. I don't want to be on my computer. I don't want to be on the phone.

JUDGE LATIMORE: You don't have an Instagram or Facebook account.

MS. FERRARA: I do.

JUDGE LATIMORE: Oh, but you don't want to be.

MS. FERRARA: But at this point, I don't even look at them anymore because I'm on it all day, you know. I'm a yoga teacher so I'm on – I'm on Facebook. And I'm a photographer so I have an Instagram because I think that's a law. But I don't look at them.

JUDGE LATIMORE: All right. And you're a yoga teacher.

MS. FERRARA: Yes.

JUDGE LATIMORE: How long have you been doing that?

MS. FERRARA: Five, six years now.

JUDGE LATIMORE: And is there a specific type of yoga you teach?

MS. FERRARA: I do Hatha Yoga, and it's more slow and intentional. Like I'm not fast vinyasa. Nobody moves really fast in my classes. I'm not doing it in hot, hot rooms.

JUDGE LATIMORE: I was going to ask you that.

MS. FERRARA: No, it's really more slow, intentional so people can kind of figure out themselves in the posture.

JUDGE LATIMORE: And what do you think is the greatest benefit of yoga? If you were to tell our audience, what would you tell them about yoga and why they might consider doing it?

MS. FERRARA: So for me yoga is not just the class that you go to, it's the opportunity to know yourself better and as you know yourself better and sort of find more kindness for yourself, that moves out into the community.

JUDGE LATIMORE: Oh...

MS. FERRARA: You know there's this idea of being present for yourself that allows you to be present for more people outside.

JUDGE LATIMORE: Oh, all right, I like that.

MS. FERRARA: Yeah.

JUDGE LATIMORE: All right, so I need to join a yoga class.

MS. FERRARA: You do.

JUDGE LATIMORE: Uh-huh. So where did you grow up?

MS. FERRARA: I grew up in this little town, it's not even called a town, it's called a borough, the Borough of New Milford in New Jersey.

JUDGE LATIMORE: New Jersey.

MS. FERRARA: Um-hum, I'm a Jersey girl.

JUDGE LATIMORE: All right. Do you have a Jersey accent?

MS. FERRARA: I don't. Both of my parents were New Yorkers, so I had move of a New York accent.

JUDGE LATIMORE: What do you miss about Jersey?

MS. FERRARA: Oh, man, the food. Like the pizza, bagels. We have a – I mean, you can get it down here, but everybody has a pork roll or a Taylor ham, depends on where in New Jersey, what you call it. But really, it's the New York, New Jersey water. It's the breads.

JUDGE LATIMORE: Okay.

MS. FERRARA: You can't get it down here.

JUDGE LATIMORE: You can't get it here?

MS. FERRARA: No.

JUDGE LATIMORE: All right. Do you still have family there?

MS. FERRARA: Yes.

JUDGE LATIMORE: So you get to go have some of that every once in a while.

MS. FERRARA: I do. I do.

JUDGE LATIMORE: What is the food here that you like the best?

MS. FERRARA: Here that I like – I mean, seafood for sure, you can get –

JUDGE LATIMORE: That's your favorite.

MS. FERRARA: Well, I eat everything. I mean, I love food, but the seafood's fresher, I feel like down here.

JUDGE LATIMORE: All right. And so you consider yourself a foody?

MS. FERRARA: Yes.

MS. FERRARA: Tons of people obsess about but I don't get the hype. There's a lot in

like movies or Hollywood that people are either obsessed about things. And the more something

gets hyped, the more I'm uninterested so it kind of is a double-edged sword there. So I don't get

the hype over like the Kardashians. Like I don't get it and I will never get it. So these like

famous stars who are famous for I have no idea why, I just don't get that.

JUDGE LATIMORE: Is there anyone maybe a celebrity or author or anyone that you

MS. FERRARA: Oh, I would love to have a coffee with Alice Walker or if she was still

alive, Mary Oliver or Tony Morrison.
