JUDGE LATIMORE: Hi, I'm Judge Alicia Latimore.

MR. DIAMANI: Hi, I'm Jonathan Diamani.

JUDGE LATIMORE: And you're listening to 9th Unplugged.

JUDGE LATIMORE: Okay.

MR. DIAMANI: I think I'm okay.

JUDGE LATIMORE: How long have you been playing softball?

MR. DIAMANI: About four years, but I played baseball for eight years when I was younger.

JUDGE LATIMORE: Okay. Are you a member of a team like an A team, or –

MR. DIAMANI: Yes, I currently play in a league in Altamonte and then I travel like around Florida.

JUDGE LATIMORE: What's your position?

MR. DIAMANI: I play the outfield.

JUDGE LATIMORE: Okay. All right, well, wonderful. Do you have uniforms and a team name, and all that?

MR. DIAMANI: Yes, we do. The team name is called Good Times.

JUDGE LATIMORE: Good Times. Who came up with that name? That's great. All right. Well, that sounds fun. So when you – where are you travelling, all around Florida to do that?

MR. DIAMANI: Yes, depending where the tournament is, we could go to Viera, we go to Titusville, De Leon Springs, anywhere, anywhere in Florida, or even outside of Florida but most of the time it's here in Florida.

JUDGE LATIMORE: Any other sports that you do?

MR. DIAMANI: At the moment, no.

JUDGE LATIMORE: All right. You can swim though, apparently.

MR. DIAMANI: Yes.

JUDGE LATIMORE: Because I understand you used to be a lifeguard at Aquatica?

MR. DIAMANI: Yes, ma'am.

JUDGE LATIMORE: So I'm glad that you know how to swim being a lifeguard. So how was that experience?

MR. DIAMANI: It was nerve racking at the beginning because you had to like act, you cannot hesitate, but you also have to do it safely because you can't hurt other people. But it was fun. After a while, it's like second nature.

JUDGE LATIMORE: Yeah, just to share just a fun fact, I used to be a lifeguard when I was younger.

MR. DIAMANI: Nice.

JUDGE LATIMORE: And so it's always interesting how young kids just jump in the water and they don't know how to swim and they're fearless. Did you have that experience?

MR. DIAMANI: Yes. And all the time their parents, oh, they know how to swim when they're like clearly almost drowning.

JUDGE LATIMORE: Right, yeah, they're going under, ma'am, let me help that child now, okay, because apparently you have more confidence than we do. Okay. All right, and how long did you do that?

MR. DIAMANI: I did it for like three years. I started in Aquatica, then I went to this hotel called Westgate, that they opened up a water park called Ship Wreck Island and then I worked – I actually was part of the opening team for Volcano Bay.

JUDGE LATIMORE: Okay, second nature to you.

MR. DIAMANI: Yes.

MR. DIAMANI: I do.

JUDGE LATIMORE: How many siblings do you have?

MR. DIAMANI: I would say plus eight.

JUDGE LATIMORE: Plus eight.

MR. DIAMANI: Yes.

JUDGE LATIMORE: Okay, but you said that you're an only child.

MR. DIAMANI: Yes.

JUDGE LATIMORE: How does that work?

MR. DIAMANI: So they're all from my father's side.

JUDGE LATIMORE: Okay. All right. And do you have get-togethers or family reunions where you bring everybody together?

MR. DIAMANI: I, technically we found out about each other when he passed because not even our mothers knew that there was more kids.

JUDGE LATIMORE: Oh, that's a surprise.

MR. DIAMANI: Yes, a big one.

JUDGE LATIMORE: Okay. All right, have you been able to develop relationship with –

MR. DIAMANI: Yes, I have.

JUDGE LATIMORE: Good. Good. All right, well, that's a blessing actually, to know that you have other relatives out there.

MR. DIAMANI: Yes.

JUDGE LATIMORE: All right, so tell me this, what is it that you have not done in your life that you really look forward to experiencing in the future?

MR. DIAMANI: Like a hobby or like goals?

JUDGE LATIMORE: Whatever you like.

MR. DIAMANI: Oh, that's a good question.

JUDGE LATIMORE: Good question.

MR. DIAMANI: Maybe jump out of airplanes.

JUDGE LATIMORE: Interesting. I could introduce you to someone who happens to work in this building that you could do that with, okay. Listen to the podcast; you'll find out, okay.

MR. DIAMANI: Okay, will do.

JUDGE LATIMORE: And what is something that you'd never do again?

MR. DIAMANI: Something that I would never do again.

JUDGE LATIMORE: Difficult question.

MR. DIAMANI: Yes.

JUDGE LATIMORE: So everything you've done, you'll do that all over again one more time.
