JUDGE LATIMORE: Hi, I'm Judge Latimore.

MR. SEMINO: And I'm Julio Semino.

JUDGE LATIMORE: And you're listening to 9<sup>th</sup> Unplugged.

JUDGE LATIMORE: Before we unplug from work and dive into life outside of the courts, tell us your title and which department you work in?

MR. SEMINO: Sure. I'm the court support manager and I work pretty much in the court support department, which is communications and jury.

JUDGE LATIMORE: They're still there.

MR. SEMINO: Except for you know like my kids and you know immediately family here. My whole family lives down there. I miss the close connection to the beach because you just hop on 836 and before you know it, South Beach. And just I think back when I was a kid Miami – it's all right, because back when I was a kid Miami was more like Orlando now so back then it was really bubbly. Now it's just like over, over populated but –

JUDGE LATIMORE: Yeah.

MR. SEMINO: I miss that.

JUDGE LATIMORE: Yeah, it seems like Orlando has kind of headed that way, right.

MR. SEMINO: Right.

JUDGE LATIMORE: Right. All right. So before you got into the court system, what were you doing as far as your career?

MR. SEMINO: Oh, well I was you know a sort of stay at home dad, working – like I said, my wife was a court reporter and we had a firm. So it was probably office manager you would call it, running the business.

JUDGE LATIMORE: All right. What do you do for fun when you're not at work?

MR. SEMINO: When I'm not at work, a little bit of everything. I like playing pool. I like playing tennis.

JUDGE LATIMORE: Are you good?

MR. SEMINO: I'm decent, you know, I'm better than – I'm better than your average bear but you know no pro status at all. And then I like, obviously watching TV. I like cooking, but not every day cooking. I like purposeful cooking.

JUDGE LATIMORE: What's your secret talent?

MR. SEMINO: Secret talent. I really don't have like a secret, secret talent.

JUDGE LATIMORE: I see here something about gardening.

MR. SEMINO: Well, I am pretty good at gardening. I've got a mango tree, papaya trees, key lime, lemon, pineapple –

JUDGE LATIMORE: Wow.

MR. SEMINO: A little bit of –

JUDGE LATIMORE: All on your home property?

MR. SEMINO: All in my backyard, yeah.

JUDGE LATIMORE: Backyard.

MR. SEMINO: No, backyard because you don't want people to get those fruits in the front yard.

JUDGE LATIMORE: Right, because if I'd come by your mango tree, I'm definitely raiding it, okay.

MR. SEMINO: Right.

JUDGE LATIMORE: I notice here that you also lived in four countries by the age of five.

MR. SEMINO: I did. I did. So I was born in Cuba, went to Spain. We were trying to come to the United States. Back then there was a quota system. It was pretty strict and a lot of Cubans were going to Spain, then went to Venezuela, and then eventually ended up here.

JUDGE LATIMORE: Okay.

MR. SEMINO: All by five.

JUDGE LATIMORE: Now, do you travel a lot?

MR. SEMINO: You know, I didn't really travel that much before, but whenever I get a chance, I do. So I've been to you know a bunch of places.

JUDGE LATIMORE: Is there anywhere that you'd like to visit you haven't had a chance yet?

MR. SEMINO: I haven't seen the Grand Canyon yet and I haven't seen believe it or not, Niagara Falls.

JUDGE LATIMORE: Niagara.

MR. SEMINO: So both of those I want to do.

MR. SEMINO: My kids are 23 and 21.

JUDGE LATIMORE: And what are they up to?

MR. SEMINO: Well, my daughter is a nurse. She works for Advent Health and my son is finishing up his – he's going to be a radio – x-ray tech.

JUDGE LATIMORE: Oh, okay. So you're a proud dad.

MR. SEMINO: Yeah. Yeah, they're pretty good.

JUDGE LATIMORE: How are you enjoying empty nest life?

MR. SEMINO: Good. I have a lot of free time, especially now with you know, this last year has been a little interesting dealing with COVID and so I'm a little busier than I was before outside of the home.

JUDGE LATIMORE: Do you believe there's life on other planets?

MR. SEMINO: You know I'm sure there is life on another planet. I just don't think it's anywhere nearby.

JUDGE LATIMORE: Would you like to meet anyone from another planet?
