JUDGE LATIMORE: Hey, I'm Judge Latimore.

JUDGE LATIMORE: Basketball. Professional or college?

JUDGE LATIMORE: Who's your favorite team?

MR. LUMSDEN: I'm a big – I'm a Carolina boy so I'm a big Hornets fan.

JUDGE LATIMORE: All right, well, they didn't make it now. Let's just talk about it.

Whom are you rooting for right now?

MR. LUMSDEN: We're still working on; we're still working on it.

JUDGE LATIMORE: You're still working on it. We doing Miami or the Lakers? Which one are we doing right now? Or we're not doing either one, are we?

JUDGE LATIMORE: Oh, you're saying the right thing then. I'm a Miami girl.

JUDGE LATIMORE: I know a lot of people who really do like raw oysters.

MR. LUMSDEN: Oh -

JUDGE LATIMORE: Actually, you know, there's one camp or the other. There's nobody who really straddles. It's one or the other, right. Have you met that?

MR. LUMSDEN: Yeah, but that's my go to – that's my go to seafood.

JUDGE LATIMORE: See, I'm crab. You give me crab, I can stay all day eating –

JUDGE LATIMORE: Yeah. What are you proudest of in your life?

JUDGE LATIMORE: All right. And so how are the teenage years going with that son?

MR. LUMSDEN: Oh, it's pretty good. It's kind of tough with this whole COVID thing.

JUDGE LATIMORE: Okay. And what is special about where you grew up? Where did you grow up?

JUDGE LATIMORE: All right.

MR. LUMSDEN: Population of maybe 15 to 16 thousand.

JUDGE LATIMORE: Wow.

MR. LUMSDEN: About 11 square miles. Small, a small city, northeast, North Carolina, probably about 10, 15 minutes from the North Carolina, Virginia border.

JUDGE LATIMORE: What do you miss about it?

MR. LUMSDEN: My parents. My parents are still there and most of my family is still there so – I would have to say my parents.

JUDGE LATIMORE: Yeah. And do you get to go visit there every once in a while once you get to get unplugged from the 9^{th} –

MR. LUMSDEN: Yeah, I like to visit there twice a year, during the holidays. This year I'm really not sure. My mother is kind of older so with the whole virus, I'm not sure.

JUDGE LATIMORE: What's the favorite dish that your mom cooked for you?
