JUDGE LATIMORE: Hi, I'm Judge Latimore.

MS. BECKTON: Hi, I'm Patricia Beckton.

JUDGE LATIMORE: And you're listening to 9th Unplugged.

MS. BECKTON: The big cookies, two for a nickel.

JUDGE LATIMORE: Oh, way back when they came in the brown bag, when you get to put them in a brown bag.

MS. BECKTON: Well, they were actually in the jar.

JUDGE LATIMORE: In the jar but you get to put them in the little brown bag.

MS. BECKTON: Yes.

JUDGE LATIMORE: I remember them big cookies. They were so good and the bag would get all greasy on the side.

MS. BECKTON: Yes, they were. Oh, yeah.

JUDGE LATIMORE: With the butter, okay.

MS. BECKTON: Don't take me that far back.

JUDGE LATIMORE: Don't take you that far back.

MS. BECKTON: You're tempting me to go get some cookies now.

JUDGE LATIMORE: All right, and what was the worst job you've ever had?

MS. BECKTON: I really haven't had a worst job. Oh, I know, I was working at a testing lab and we had to do microchips, and it was fast paced, and you had to do thousands and thousands. And if you didn't do it, the supervisor is on your back, like, white on rice.

JUDGE LATIMORE: Oh, goodness, so you didn't enjoy any of that. That's nothing like Judge Whitehead.

MS. BECKTON: Some times were good, because sometimes when we had good nights, he would let us go to Dairy Queen to get a sundae.

JUDGE LATIMORE: Okay.

MS. BECKTON: Yeah, so it wasn't so bad after all.

JUDGE LATIMORE: It wasn't bad at all, okay. So tell me about your family. How large is your family?

MS. BECKTON: Oh, I have a big family. I have eight sisters and seven brothers on my mom side and my dad side, so I have a very large family. And the majority of them are all here in Orlando.

JUDGE LATIMORE: That is wonderful. Tell me what you all do when you celebrate a big occasion. What does that look like?

MS. BECKTON: Oh, man. It's like food. It's like playing spades and just a lot of laughing and talking, you know.

JUDGE LATIMORE: Okay. And when it's the largest it can be, like tell me about how many people are going to be there because you have – that's a big family.

MS. BECKTON: Probably around 75.

JUDGE LATIMORE: Wow.

MS. BECKTON: Yeah.

JUDGE LATIMORE: That's a lot of food.

MS. BECKTON: Yeah, that's a lot of food and everybody cooks. And it's all good food, too.

JUDGE LATIMORE: All right, and so what's the dish that they want Ms. Pat to bring?

MS. BECKTON: Collard greens.

JUDGE LATIMORE: All right.

MS. BECKTON: Yep. Collard greens and -

JUDGE LATIMORE: Okay, so you're a collard greens specialist.

MS. BECKTON: Collard greens specialist and sweet potato pie.

JUDGE LATIMORE: Do you have a friend that you would call family?

MS. BECKTON: Shirley Washington.

JUDGE LATIMORE: Oh, and Ms. Washington was with us – with Judge Lauten.

MS. BECKTON: Yes.

JUDGE LATIMORE: Yes. All right, so do you all still keep in touch with each other?

MS. BECKTON: Yes, we do. Not as often because she retired before me. She was supposed to retire the same year that I did. Unbeknownst to me, she was retiring a year before me. JUDGE LATIMORE: Uh-oh.

MS. BECKTON: So she actually put me in retirement mode.

JUDGE LATIMORE: There you go. It was motivation.

MS. BECKTON: Yes.

JUDGE LATIMORE: Motivation for you to do that. All right, let me ask you just a couple of questions and tell me which ones you would pick. How about, are you an extrovert or introvert?

MS. BECKTON: Well, that depends on who I'm around.

JUDGE LATIMORE: Oh. So you're a little bit of both.

MS. BECKTON: A little bit of both, yes.

JUDGE LATIMORE: Okay. That makes sense. Would you pick zoo or aquarium?

MS. BECKTON: Aquarium.

JUDGE LATIMORE: Jeep or Jet Ski?

MS. BECKTON: Jeep.

JUDGE LATIMORE: Jeep.

MS. BECKTON: Heck yeah. I'm afraid of the water.

JUDGE LATIMORE: Are you.

MS. BECKTON: Yes.

JUDGE LATIMORE: Are you. Do you swim?

MS. BECKTON: I am what you would call a minnow.

JUDGE LATIMORE: A minnow.

MS. BECKTON: Yeah, my sister and I took – actually took swim lessons at the YMCA one year. And we graduated as minnows but that wasn't as bad as the tadpole.

JUDGE LATIMORE: Oh, okay. That's right, you're at least one up.

MS. BECKTON: Yes.

JUDGE LATIMORE: Okay.

MS. BECKTON: So I can float on my back. And I can't tread water because I'm afraid of the water so – but other than that, I'm okay.

JUDGE LATIMORE: Okay.

MS. BECKTON: I'll splash and play on the edge.

JUDGE LATIMORE: You will survive.

MS. BECKTON: I will.

JUDGE LATIMORE: What gives your life meaning?

MS. BECKTON: Family.

JUDGE LATIMORE: Okay. And how is your life different than what you may have imagined it to be when you were younger?

MS. BECKTON: When I was younger, it's almost what I would have imagined it to be because when I was younger I always wanted to be a legal secretary. But then I, as I got older, you know, went through school and stuff, and I started working at UPS so I kind of like threw that under the bus.
