JUDGE LATIMORE: Hi, I'm Judge Latimore.

MR. PRIDEMORE: Hi, I'm Paul Pridemore.

JUDGE LATIMORE: And you are listening to 9th Unplugged.

We get a lot of visitors from people in Kansas City to the guys in the Bahamas, to the guys over in Puerto Rico. Pretty much anyone that is trying to do new courtroom technology comes and talks to us. So it's exciting.

MR. PRIDEMORE: The worst job was probably also the most fun job that I ever had and I say the worst job because monetarily speaking, you didn't get paid very much, but we had a blast. And that was working at AMC Theaters. So I was one of the first projectionists that was out at the Downtown Disney complex or at the AMC Pleasure Island. So my very first movie when I was like 15 or 16 that I started working was the Lion King. And then I worked there for like 12 years total, probably way too long.

MR.
