JUDGE LATIMORE: Well, hello, I'm Judge Latimore.

MR. DESMOND: And I'm Ryan Desmond.

MR. DESMOND: But typically, we would go camping and go hiking. My kids are very

much into soccer, which of course we're also not doing right now. But yeah, a lot of you know

sports and activities outdoors really.

JUDGE LATIMORE: Did you do sports when you were growing up?

MR. DESMOND: I always had a lot of friends that were on the teams and I never was but

I always played sports with them so I guess, yes, I did, but I had never really been on the teams

and into it as much as some people.

JUDGE LATIMORE: All right, so where were you born and raised?

MR. DESMOND: So I was actually born in Minneapolis, Minnesota. And when I was

about five years old, moved to St. Petersburg, Florida. And I grew up there primarily and found

myself in Orlando when it was time to go to college. I went to UCF.

JUDGE LATIMORE: Okay. And if you had a place that you'd like to choose to live outside
