JUDGE LATIMORE: Hi, I'm Judge Latimore.

MS. MORRIS: Hi, I'm Suzanne Morris.

JUDGE LATIMORE: And we are on 9th Unplugged.

coaster is. We kind of pull away from that.

MS. MORRIS: Yeah.

JUDGE LATIMORE: But does she really enjoy the roller coasters?

MS. MORRIS: For the most part she does. She's still, you know, a little nervous because she's still at that age but I told her in a couple years, she's probably going to want to do everything. But yeah, so it's mostly just spending time with her and my husband.

JUDGE LATIMORE: Okay. And are you originally from Orlando?

MS. MORRIS: No.

JUDGE LATIMORE: Where are you from?

MS. MORRIS: I – well, I've been here so long, it almost feels like it. I've been here since 2007. But I'm originally from the Hampton Roads area of Virginia.

JUDGE LATIMORE: What brought you here?

MS. MORRIS: Actually, my brother moved down here first. And then I was kind of at a transition phase in my life and was just like, I'm going to go down there with him and –

JUDGE LATIMORE: There you go.

MS. MORRIS: -- just been here ever since.

JUDGE LATIMORE: There you go. So welcome to Florida too. So with that, you – I

understand you have a podcast yourself.

MS. MORRIS: I do.

JUDGE LATIMORE: Nice. Okay, so teach me something so I can do better.

MS. MORRIS: Oh, man, I was hoping to learn from you.

JUDGE LATIMORE: Tricked you.

MS. MORRIS: It's a little different format because we don't – we don't interview people.

JUDGE LATIMORE: Tell us about it.

MS. MORRIS: It's me and a friend of mine, we go to the same church and it just kind of

came out of us having these long conversations. And her husband was just like, you guys should

start a podcast. And I was like, because I knew quite a few people that when I would talk to them

Didn't expect it, but when I came across Biblical Hebrew, I was like, oh, wow, that sounds interesting.

JUDGE LATIMORE: Yes.

MS. MORRIS: And ever since then I'm just like – just anything I can to try to learn like – it's just to me personally brought a new level of depth in understanding. When I'm reading my Bible, understanding the original contacts, the original words, what it meant to them when they said certain things because it's not always what we think in our understanding. Our western view is very different from their view and so it's just like – to me it's like a treasure hunt.

MS. MORRIS: Like, oh my gosh, what was the original word? What did it originally

mean?

JUDGE LATIMORE: What did it really mean?

MS. MORRIS: Yeah, like it's just exciting to me so I love it.

JUDGE LATIMORE: That's wonderful. That is quite interesting.

MS. MORRIS: Yeah.

JUDGE LATIMORE: I would love to know what your secret talent is.

MS. MORRIS: Do I have a secret talent? If you were to ask the people closest to me, they

would say my secret talent is knowing the outcome of something before it happens.

JUDGE LATIMORE: Oh.

MS. MORRIS: Because I am extremely analytical.

JUDGE LATIMORE: Okay.

MS. MORRIS: And my degree is in psychology so like I already have a little bit of a

psychological background like – and so they sometimes won't tell me things because they know

I might tell them an outcome they don't want to hear. But I don't claim that I predict anything.

I'm just really good at analyzing situations and being able to –

JUDGE LATIMORE: An intuition.

MS. MORRIS: Yes, exactly.

JUDGE LATIMORE: Okay.

MS. MORRIS: I can just be like, this is – or I can see the root of something. If someone starts telling me something is going on in their life, I can kind of probably get to the root of it without them having to tell me.

JUDGE LATIMORE: Yeah.

MS. MORRIS: So that's my secret.

JUDGE LATIMORE: So remind me not to tell you anything, okay.

MS. MORRIS: Yeah, people tell me that all the time, like, let me be careful what I say around you.

JUDGE LATIMORE: I don't really want to know, okay, how this is going to turn out.

MS. MORRIS: Nothing in the legal field.
