NINTH JUDICIAL CIRCUIT CIRCUIT CIVIL JURY TRIAL LIST

Please note the following important information:

- A. Attorneys and clients for the cases listed below shall report, in-person, on Friday, May 14, 2021, at 8:30am. to Courtroom 4-C and Courtroom 4-D (see assignments below) to begin jury selection. Once a jury is selected, parties will begin jury trial in the assigned courtrooms below on Monday, May 17, 2021.
- B. The jury venire will consist of 25-30 individuals. A jury must be selected within one day (Friday, May 10, 2021) and each side will receive <u>2 hours for jury selection</u>.
- C. COVID protocols including social distancing still remain in effect. Attorneys and clients must be socially distant from one another in the courtroom and wear masks. Face shields alone are not permitted. Remember, witnesses may appear virtually, and a CISCO link appears below. Attorneys should make certain virtual witnesses have a current ID and proper equipment/bandwidth to testify during trial along with copies of any exhibits. Finally, per COVID protocols, attorneys must remain at the lectern and are not permitted to unnecessarily move around the courtroom to maintain socially distancing.
- D. All exhibits and evidence must be pre-marked prior to trial. According to the Clerk's Office, evidence instructions and tags are available at the Ninth Circuit Courthouse, Monday to Friday from 7:30 a.m. to 4:00 p.m., in the Records division located in Room 130.
- E. If a case settles, the JA must be immediately notified of any settlement or resolution of any matter or of any parties to any matter, on the trial docket. The trial will not be removed from the actual docket, is subject to trial call, and the attorneys must appear in-person, until such time as the Court receives <u>written notice</u> that the matter has been fully resolved <u>and</u> all documents necessary to close the case have been filed with the Clerk. A Notice of Settlement is not sufficient to close the case. A dismissal or judgment as to all defendants/claims is required.
 - F. Jury instructions are due 5 days prior to trial.
- G. The jury room will provide the venire with <u>clear masks</u> to wear during jury selection, but based on previous experience, these masks are uncomfortable for potential jurors to wear. Attorneys should meet and confer as to whether they want the venire to wear their own masks or clear masks. Additionally, we will also provide clear masks to the attorneys for their live witnesses to wear, if they wish.
- H. Please refer to each respective division's guidelines and procedures for additional requirements for trial.
