IMPORTANT INFORMATION REGARDING OTHER HEARINGS

- As of 6/29/20, at the courthouse we will have "virtual courtrooms" set up in the Jury Assembly Room (Room 180 on the 1st floor). From these "courtrooms," Defendants who are out of custody, and their attorney, will be connected to the Judge via video for pleas, arraignments and other essential hearings as designated by the Court only. Division 12 is assigned to "Jury Courtroom 1," unless otherwise specified.
- Defendants in custody whose appearance cannot be waived, will appear virtually from the BRC (at the Jail), with their attorney, for pleas, bond hearings and other essential hearings, as designated by the Court. (Please note which BRC Courtroom is being utilized in your Notice of Hearing.)
- If appropriate, hearings, statuses, and other matters will be set for "virtual hearings" via videoconference. The Court encourages the parties to make use of Virtual Hearings for evidentiary hearings. - For Defendant's that are in custody, but cannot be transported to the BRC because they are subject to quarantine, please inform the Court, as arrangements can be made for video appearance depending on their location within the Orange County Jail.
- Any attorney requesting to appear via videoconference for ANY HEARING should inquire with the Judicial Assistant, Lauren Burrows, at CTJALB1@ocnjcc.org to obtain a link for a remote appearance.

- 3. If applicable, **YOU MUST ALSO E-FILE** your motion/form as indicated below:
 - (a) Motion to Continue
 - (b) Notice Case Will Resolve by Plea
 - (c) Participation in Diversion or Specialty Court
 - (d) Request for Jury Trial and Waiver of Appearance at VPTC.

- 4. **ONLY IF** a Motion to Continue was e-filed, **YOU MUST EMAIL** your Proposed Order Granting/Denying Motion to Continue to the Judicial Assistant Lauren Burrows at CTJALB1@ocnjcc.org.

- 5. GoogleForm® Responses for VPTCs and Applicable Forms/ Motions are due by 5pm on the Monday immediately prior to your scheduled VPTC date.
- 6. Attendance at Virtual Hearings by the State and Defense at VPTC are **REQUIRED IF**:
 - (a) a timely response is not submitted by Defense via GoogleForm®;
 - (b) any party requests to appear virtually; or
 - (c) a case is selected by the Court to appear for a VPTC hearing.
