**ORDER FOR MONITORED VISITATION EXCHANGE  
(Overnight Unsupervised Visitation)**

After hearing evidence that established that the parties have not or can not pick up and drop off their child(ren) for visitation in a neutral and/or at an agreeable location which is safe for the children, either physically and/or emotionally, the Court hereby orders the parties to use the Family Ties Monitored Exchange services for:

It is hereby **ORDERED** and **ADJUDGED** that:

1. Both parties shall contact the **Family Ties** office at **(407) 836-0426** within **five (5) business** days of the date of this Order to begin the process of scheduling mandatory orientations and monitored visitation exchanges. Failure to contact the **Family Ties** office within said time may result the family not being able to use the **Family Ties** services and the Court issuing sanctions against the responsible party or parties.

2. Monitored exchanges conducted in any of the **Family Ties** locations shall be coordinated and scheduled during hours established by **Family Ties, excluding** Court Holidays. Any monitored exchanges conducted at the Orange County Courthouse shall be completed no later than 4:00 p.m.

3. Monitored visitation exchanges will be ( ) every week ( ) every other week ( ) Other \_\_\_\_\_ and shall take place as follows:

**A. PICK UP OF THE CHILD(REN) BY VISITING PARENT:**

**B. RETURN OF THE CHILDREN:**

- ( ) Return of the child(ren) shall be scheduled and conducted by **Family Ties** at the Orange County Jail Campus on ( ) Wednesday ( ) Friday during **Family Ties evening** hours.

The parties are encouraged to establish their own visitation arrangements during the time period of the five monitored exchanges. If the parties do establish their own visitation exchange plan, they should enter into a written stipulation stating their plan. Stipulation forms will be provided at the **Family Ties** office. If the parties are unable to agree on other arrangements, the monitored visitation exchanges will continue until further Order of the Court or non compliance of either party.

4. The cost of the service is:

( ) \$15.00 **per monitored exchange**, (\$7.50 each) to be paid equally by both parents.

Said payment shall be paid to the Domestic Clerk's Office, 425 N. Orange Ave., Ste. 320, Orlando, FL 32801, Monday through Friday, 8 a.m. until 4:00 p.m. Said payment shall be made no later than the Wednesday before the scheduled monitored exchange visitation.

The failure to pay may result in the monitored visitation exchange being canceled and/or the non complying party being ordered before the Court for contempt proceedings.

5. The parties shall follow the rules and directives of the staff of the **Family Ties** program and law enforcement agency at all **Family Ties** locations. Failure to follow said rules and directives may result in the family being removed from the **Family Ties** program and/or the Court entering sanctions against the responsible party.

6. The parties shall notify the **Family Ties** program at (407) 836-0426 at least two (2) **business** days before the scheduled monitored visitation exchange if they cannot keep a scheduled monitored visitation exchange. Failure to do so will result in the parties being required to pay for the scheduled monitored visitation exchange. If two scheduled exchanges are canceled by either party within 30 days, said cancellations will be reported to the Court and no additional monitored visitation exchanges will be scheduled until further Order of the Court.

7. The **Family Ties** and law enforcement personnel at all **Family Ties** locations shall implement this Order by all lawful means to accomplish its purpose in providing safe and regular contact between the child(ren) and visiting parents.
